# DOCOF GENERAL MEMBERSHIP MEETING MINUTES

## September 3, 2022

### Dog Training Club of St. Petersburg

Meeting called to order at 1:05 PM

Board members present: Ron Seeley, Ken Kincaid, Terri Bell, Lodge Weber, Carolee Boyles

Delegates present see sign up sheet.

#### **Minutes of previous meeting:**

Loni Coleman moved Deb Neufeld seconded to accept the minutes of the 2021 meeting as printed in Doings. Approved.

Ron expressed disappointment at the low turnout for this year's DOCOF, especially since we now can since we now can earn legs at DOCOF. The good news is that we can now earn AKC legs and titles here.

**Secretary's report:** No activity other than taking minutes at the meeting.

**DOCOF 2023 business:** Carol Ann Klein is not here to talk about judges, since she is ill with COVID. Ron asked for suggestions for judges for 2023.

Deb suggested Cheryl Pratt, who does both rally and obedience.

Terri Bell suggested Helen Smith.

Deb suggested Rick Cox.

Ken suggested Marina Pavlovsky.

Carolee suggested Nancy Heidt for rally only.

Ron has been working on the possibility of incorporating the ability to earn rally legs into DOCOF the same way we're doing with obedience. He sent ideas to the committee but hasn't heard back from the committee members.

Discussion followed about ways to add rally trial to the weekend. Several people felt that adding rally would bring in more participants.

Ken pointed out that there are a lot of people who don't know what DOCOF is. We aren't allowed to have the email addresses of club members, so we can't promote DOCOF to individual people; we have to rely on the clubs to promote DOCOF. There are a lot of new people in clubs who don't know who we are or what we do. This has always been a problem.

What this amounts to is that we are now discussing whether DOCOF is relevant enough to sustain.

Loni said we need to market DOCOF at obedience and rally trials.

Contact with clubs is difficult, and even when we communicate with them, they don't always inform their membership. Aimee said training clubs do a better job, perhaps because they are smaller than other dog clubs.

Jeanette Rodgers suggested doing an open house to invite clubs to come and get interested in DOCOF. She said maybe we need to have a fun statewide get together to generate interest.

Dorothy Herman thanked the board for serving. She said there's a lack of interest in the DOCOF weekend, and said we need to put the responsibility for generating interest back on the clubs, not on the board.

Ron said one thing is that DOCOF has changed. We used to have a lot of ancillary things, such as a BBQ. We don't do those things anymore. Loni said we can do a BBQ and Ron asked her if she would do one for next year.

Also, Pics & Pages aren't here because they aren't getting enough business for them to come. Other photographers have declined coming because they don't have the manpower.

What followed was some general discussion that if we add the ability to get rally legs, we may generate some more interest.

Carolee said we need to find a way to get in touch with individual members without relying on the clubs. One way might be to have something to give individuals who sign up for our mailing list, so we can build a mailing list. This is something that retailers do.

Deb already has a mailing list that she can send to. She is willing to send out emails for DOCOF if we provide them to her.

More discussion followed. Bobbi Graves said it needs to start with the delegates. They need to promote it. The board can't be expected to do it on their own. We aren't going to survive unless we do that.

Jan Wencil went back to the idea of reaching out to individuals who are not part of the hierarchy of clubs. We need to talk to them and get them asking their clubs "Why aren't we doing this?" We need to talk about history and why this is important.

Loni does a 3-fold brochure for Dog Training Club of St Petersburg. She livestreamed some practice runs on Facebook the day before the meeting and got a number of shares and hits. That has good value because it's live and current. It gives people a reason to engage.

Other ideas: We could print posters to hang up at the clubs. We could have DOCOF members go out and talk about DOCOF to clubs. We could print a handout to give people to take home from trials.

Because we're a seasonal event, we don't send out information all year. So, we're not visible all year. If we send out an issue of Doings in January, we might get more people interested in being on the rosters for the clubs.

Deb suggested that we change the rules for the roster, so the deadline is later in the year to give us time to recruit more people for rosters and teams. Deb moved to change the 6-month rule to 3 months, that

is, you must be associated with a club or organization for that long to be on a DOCOF team for that organization. Jeanette Rodgers seconded. Ken asked if this is a rule or is in the bylaws. Deb found it and said it's a rule, not in the bylaws. This change would set the deadline as June 1. We would also need to change the language of our rules that say someone must be associated with a club for 6 months to 3 months to participate. Passed unanimously.

Terri went back to the ideas of posters and brochures. Are we going to pursue that? Ron said we don't have a lot of income, and without extra income we can't afford it.

Ken said K-9 performance solutions will pay for the brochures and posters. Luci said if we do that, she will send them to the corresponding secretary of every dog club in Florida.

Ron asked if we should pursue an obedience seminar for next year as a fundraiser. Deb suggested Adele Yunck. Aimee will contact her.

**Membership committee:** Deb has an application from K-9 Performance Solutions. Aimee spoke about KPS. It is a membership-based training organization. Lot of hard-working obedience people train there. Part of the reason KPS is joining is simply to support DOCOF.

The vote to accept KPS into membership was 10 yes, 0 no.

**Treasurer's report:** Lodge said our account showed \$12,810.66f as of August 31, 2022. We had two successful fund-raising events during the year, the Pat Hastings seminar and the Maggie Eslinger seminar. He reminded DOCOF members to pay their dues for the upcoming year.

**Election:** Deb moved to elect the existing slate of officers and board. There were several seconds.

But Ken said he does not want to run again this year.

Deb nominated Ron Seeley for President. There were several seconds. He said he will stay on for one more year.

Deb nominated Loni Coleman for 1<sup>st</sup> VP. Ken seconded. Loni accepted.

Luci nominated Terri Bell for 2<sup>nd</sup> VP. Terri accepted.

Treasurer: Lodge will stay on.

Secretary: Carolee will stay on.

The vote to accept this slate was unanimous.

**Unfinished business:** Ken recommends that we do away with the website. Nobody uses it, and it's expensive. We can put forms and information on Facebook.

Deb moved to do away with the website. There were several seconds. The vote was unanimous in favor of the motion.

Ken will continue publishing Doings.

**New business:** None. **Motion to adjourn.** 2:21 PM

# Positions We Need to Fill

## Raffle Table:

Deb Neufeld has stepped down as the person overseeing the Raffle table for DOCOF. Deb has been doing that job since the as long as I can remember. The raffle always brings in a nice income for DOCOF and so many of your members donate great items that they put together to raffle off. Therefore, I am looking for a volunteer to take over for Deb. This job would require you to work the raffle table and walk around selling raffle tickets during the DOCOF weekend. It of course would be easier if 2-3 people helped so if you are interested, please contact Ron Seeley.

## RING PRACTICE OPPORTUNITIES

Please take the time to read the Run-through procedures and share with your team members. SET UP & TEAR DOWN Set up start time for Friday of DOCOF weekend will be announced as we get closer to Labor Day. DOCOF team areas may only be set up AFTER all of the rings and equipment are completely set up. That includes cleaning the ring mats. Do not attempt to put up your team tables and decorations before the announcement to do so is made (after the work for the event is finished). If you bring a dog, you may set up only the crate for your dog while you help with the set-up work. Team captains should be aware that those listed as tear down helpers on entry forms MUST STAY for the complete tear down of the rings at the end of the competition on Sunday. One or two rings are left up longer so that awards may be presented. This area must be broken down and mats rolled before the tear down crew leaves. The Event Committee will decide what action is to be taken if your team members do not fulfill this responsibility: It could affect your future team entries. We appreciate your cooperation so that all the events will run smoothly. In an ongoing effort to prevent excited teammates from ruining the performance of the dogs working in surrounding rings, team captains are again asked to coach handlers on their teams to remember that other teams are showing. Gentle applause is okay, but screaming and shouting should be curbed. If you wouldn't want it to happen to you during your turn in the ring, don't do it to someone else! Thanks for your good sportsmanship. Save your voices for cheering and palms for loud clapping at the end-of-day awards presentation.

## RING PRACTICE PROCEDURE

Run-through practice donations have been a great fund-raiser for DOCOF. Please come on Saturday and support your tournament generously. If you come and help us set up on Friday night, you will be able to get in an extra run-through after all the tournament preparations have been set up! This includes steward tables and raffle and trophy tables. Friday Evening – Run-throughs for donations and after setup crew is finished will be available after set-up is completed. ONLY those folks who help with set up are eligible. Run-throughs end no later than 9:00 PM. **Saturday** – Run-throughs for donations will be available to all after the Rally Event has completed. Run-throughs end no later than 9:00 PM. All normal ring practice rules apply. Practice donations: \$5 for 5 minutes; no consecutive runs; No group exercises. Procedures: You must purchase a ticket before putting your name on the sign-up board. Tickets (\$5 for 5 minutes Novice/Open; \$10 for 10 minutes Utility; \$1 per dog per set of groups) are available for purchase at the Run-through table located in front of the Raffle tables. Run-throughs will be done on a time-slotted basis. Each block of time will be 5 minutes. Dry erase boards holding the signup sheets with times on them will be at each ring. When you purchase your ticket, you will go to your ring and sign up for a block of time—5 minutes or 10 minutes. Groups will be done in alternating rings once every 45 minutes to an hour. Timers will be located at each table and each person, whose turn it is, must start the timer upon entering the ring. Each ring can handle between 8-12 dogs per hour. As you enter the ring, please cross your name off the signup sheet. No names can be moved up. If you are not ready when it is your turn, your name will go to the bottom of the list, or, you will lose your turn. Please be mindful of your time and be ready to vacate the ring when you have reached your 5 or 10 minutes. When needed, please assist by helping with a run-through, being a post, or resetting jumps. Please be respectful of other exhibitors' turns and times. **Sunday** – Begins the DOCOF Obedience SET Trial.

## STEWARDS

Remember, one full day steward or two half-day stewards are required per each team entered. Morning stewards need to report in by 7:00 a.m. on Sunday. Afternoon stewards please report in BEFORE GROUPS to ensure full coverage for stays. REPORT TO THE CHIEF RING STEWARD.

***Thank you, stewards. Not only are you enabling your team to compete, but you're also playing a huge part in making this tournament possible!***

## TOURNAMENT CRATE SPACE

There will be no food preparation. Electricity is NOT available. Clubs must make the best use of their allotted space. Please keep tables and chairs at a minimum. Crate space for each team will be marked out ahead of time. This allows all clubs to have reasonable space. If your team does not need all of its allotted space, please feel free to share with others around you. If you need more space than allotted, please stack crates (including under your lunch tables) and stack coolers on crates, etc. Please make sure things are stable when stacking them! Teams who are new or clubs/schools sending more or fewer teams than in previous years will be assigned a team space once entries are closed based on available spaces.

## Tournament Scoring

Since this is a Special Event Trial, SET, scores will NOT be available until the class is complete, just like any AKC Obedience Trial. In Utility, Directed Jumping will be scored as two (2) separate exercises for the Team score. However, for a dog entered in the SET, it will be scored as one (1) score just like any AKC Obedience Trial. Judges' scoresheets shall reflect the separate scoring, and the Trial Secretary will combine the scores for dogs entered in the SET. If anyone feels there is an error in their score, please have your Team Captain approach the Trial Secretary to resolve any issues. **NOVICE DOGS:** Any Novice dog that is entered in the SET and NQ's an exercise, will NOT be allowed to participate in Group Stays. **HOWEVER,** that same dog will be allowed to participate in Group Stays for a TEAM score, in a separate ring or after the Novice class is completed, whichever is available.
